Said Assignor hereby warrant and represent that, at the time of execution and delivery of these presents, said Assignor were the lawful owners of the entire right, title, and interest in and to said inventions and said applications for Letters Patent, and that the same had not entered into any assignment, contract or understanding in conflict herewith.

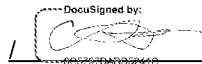
