

The purpose of this Patent Assignment Agreement is to confirm Company's ownership of such issued patent.


The parties agree as follows.

This assignment includes all claims, actions, and demands arising out of the Assigned Patents, including actions for past, current, or future infringement of the Assigned Patents and the right to collect and retain all proceeds and damages for such actions.
2. **COOPERATION.** Assignor shall cooperate with Recipient in recording this agreement with the relevant governmental authorities.
3. **MISCELLANEOUS.** This agreement is governed by California law. The parties are signing this agreement on the date stated in the introductory clause.
