RELEASE OF SECOND LIEN SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECOND LIEN SECURITY INTEREST IN INTELLECTUAL PROPERTY (the "*Release*") dated September 19, 2023, is made by Credit Suisse AG, Cayman Islands Branch, as collateral agent (in such capacity, the "*Collateral Agent*") for the Secured Parties in favor of Hyland Software, Inc., an Ohio corporation (the "*Grantor*"). WHEREAS, the Grantor executed and delivered to the Collateral Agent that certain Security Agreement, dated July 7, 2017 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered that certain Intellectual Property Security Agreement Supplement, dated April 2, 2018, in favor of the Collateral Agent (the "*IP Security Agreement*"), which was recorded with the United States Patent and Trademark Office on April 9, 2018 at Reel/Frame 045870/0389;

WHEREAS, pursuant to the Security Agreement and the IP Security Agreement, the Grantor granted to the Collateral Agent for the ratable benefit of the Secured Parties, a security interest (the "Security Interest") in the Additional Collateral, including the Patents set forth in Schedule A; and

WHEREAS, the Grantor has requested and the Collateral Agent has agreed to release the Security Interest in the Additional Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby, without recourse, representation, warranty or other assurance of any kind, (i) terminates the IP Security Agreement, (ii) terminates, cancels and releases the Security Interest in the Additional Collateral (including the intellectual property set forth on the Schedule hereto), and (iii) re-assigns to the Grantor any, right, title and interest it may have in such Additional Collateral pursuant to the Security Agreement and the IP Security Agreement. The Grantor, or any successor to the Grantor (including any person or entity hereafter holding any right title or interest in the Collateral) is hereby authorized to record this Release in the United States Patent and Trademark Office. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
