## ACKNOWLEDGEMENT OF SECURITY INTEREST IN PATENTS

THIS ACKNOWLEDGEMENT OF SECURITY INTEREST IN PATENTS (this "Agreement"), dated as of September 28, 2023, is made by the undersigned (individually each the "Grantor" and collectively the "Grantors"), in favor of THE HUNTINGTON NATIONAL BANK as Administrative Agent (in such capacity, the "Administrative Agent").

### W I T N E S S E T H:

WHEREAS, Grantors entered into that certain Security Agreement, dated as of September 28, 2023 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), among the Grantors, certain affiliates of the Grantors and the Administrative Agent; and

WHEREAS, pursuant to the Security Agreement, the Grantors granted to the Administrative Agent, for its benefit and the benefit of the Secured Parties, a security interest in the Grantors' Intellectual Property (as defined in the Security Agreement), including, without limitation, Patents and Licenses (each as defined in the Security Agreement); and

WHEREAS, each Grantor has duly authorized the execution, delivery and performance of this Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the parties hereto agree as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, capitalized terms used in this Agreement, including its preamble and recitals, have the meanings provided or provided by reference in the Security Agreement.

SECTION 2. Grant of Security Interest. Each Grantor hereby confirms that pursuant to the Security Agreement, the Grantors granted to the Administrative Agent, for its benefit and the benefit of the Secured Parties, a security interest in all of the Patents and Licenses of the Grantors (including, without limitation, those items listed on Schedule A hereto), any and all goodwill associated therewith, and all proceeds and products of any and all of the Patents of the Grantors, to secure the payment and performance of the Secured Obligations.

SECTION 3. Purpose. This Agreement has been executed and delivered by the Grantors for the purpose of recording the security interest granted pursuant to the Security Agreement with the United States Patent and Trademark Office. This Agreement is expressly subject to the terms and conditions of the Security Agreement. The Security Agreement (and all rights and remedies of the Administrative Agent thereunder) shall remain in full force and effect in accordance with its terms.

SECTION 4. Acknowledgement. Each Grantor hereby further acknowledges and affirms that the rights and remedies of the Administrative Agent with respect to the security interest in the Patents are fully set forth in the Credit Agreement and the Security Agreement, the terms and

provisions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein.


SECTION 5. Counterparts. This Agreement may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original. Delivery of an executed counterpart of a signature page of this Agreement by facsimile or in electronic (e.g. "pdf" or "tif") format shall be effective as delivery of a manually executed counterpart of this Agreement.


