ASSIGNMENT

AND MARCTEC LLC HEREBY authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to the said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

AND MARCTEC LLC HEREBY covenants and agrees that MARCTEC LLC has full right to convey the entire interest herein assigned, and that MARCTEC LLC has not executed, and will not execute, any agreement in conflict herewith.

AND MARCTEC LLC HEREBY further covenants and agrees that MARCTEC LLC will communicate to the said ASSIGNEE, its successors, legal representatives and assigns, any facts known to MARCTEC LLC respecting said MarcTec inventions, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing, reissue and foreign applications, make all rightful oaths, and generally do everything possible to aid the said ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper protection for said MarcTec inventions in all countries.

AND MARCTEC LLC HEREBY grants the firm of Fleit, Gibbons, Gutman, Bongini & Bianco P.L. the power to insert into this Assignment any further identification which may be necessary or desirable to comply with the rules of the United States Patent and Trademark office for recordation of this Assignment.


