## INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Intellectual Property Security Agreement is entered into as of October 11, 2023 by and between WILMINGTON TRUST, NATIONAL ASSOCIATION, as collateral agent (“Collateral Agent”), and PROSOMNUS, INC. (the “Borrower”), PROSOMNUS HOLDINGS, INC. (“Holdings”) and PROSOMNUS SLEEP TECHNOLOGIES, INC. (“PST” and, collectively with the Borrower and Holdings, the “Grantors”).

### RECITALS

A. Grantors have entered into that certain Subordinated Security Agreement (the “Agreement”), dated October 11, 2023, by and between Grantors and Collateral Agent. Capitalized terms used herein but not otherwise defined have the meaning set forth in the Agreement. Pursuant to the Agreement, Grantors shall grant to Collateral Agent a security interest in certain Copyrights, Trademarks and Patents to secure the obligations of Grantors under the Indenture and the Guarantee.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, and intending to be legally bound, as collateral security for the prompt and complete payment when due of its obligations under the Indenture, each Grantor hereby represents, warrants, covenants and agrees as follows:

### AGREEMENT

To secure its obligations under the Indenture, each Grantor grants and pledges to Collateral Agent a security interest in all of such Grantor’s right, title and interest in, to and under its Intellectual Property Collateral (including without limitation those Copyrights, Patents and Trademarks listed on Exhibits A hereto), and including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions, continuations, renewals, extensions and continuations-in-part thereof.

This security interest is granted in conjunction with the security interest granted to Collateral Agent for the Secured Parties under the Indenture. The rights and remedies of Collateral Agent with respect to the security interest granted hereby are in addition to those set forth in the Indenture and the other Transaction Documents, and those which are now or hereafter available to Collateral Agent for the Secured Parties, as a matter of law or equity. Each right, power and remedy of Collateral Agent provided for herein or in the Indenture or any of the Transaction Documents, or now or hereafter existing at law or in equity shall be cumulative and concurrent and shall be in addition to every right, power or remedy provided for herein and the exercise by Collateral Agent of any one or more of the rights, powers or remedies provided for in this Intellectual Property Security Agreement, the Indenture or any of the other Transaction Documents, or now or hereafter existing at law or in equity, shall not preclude the simultaneous or later exercise by any person, of any or all other rights, powers or remedies.

Each Grantor hereby authorizes (but does not obligate) Collateral Agent to file and/or record, in the relevant office(s), including the United States Patent and Trademark Office and the

United States Copyright Office, this Intellectual Property Security Agreement and any and all amendments and/or modifications hereto, including to the Exhibit attached hereto from time to time, and other documents, without the signatures of Grantors either in Collateral Agent's name or in the name of Collateral Agent as Collateral Agent and attorney-in-fact for Grantors.

This Intellectual Property Security Agreement is subject to that certain Amended and Restated Intercreditor Agreement dated as of October 11, 2023 (as amended, amended and restated, supplemented or otherwise modified, from time to time, in accordance with the terms thereof and of the Indenture, the "Intercreditor Agreement"), by and among the Borrower, the subsidiary guarantors party thereto, Wilmington Trust, National Association, as collateral agent for the December 2022 Junior Secured Parties (as defined therein), Wilmington Trust, National Association, as collateral agent for the September 2023 Junior Secured Parties (as defined therein), Wilmington Trust, National Association, as collateral agent for the December 2022 Senior Secured Parties (as defined therein), and Wilmington Trust, National Association, as collateral agent for the September 2023 Senior Secured Parties (as defined therein), and each party hereto shall be bound by said Intercreditor Agreement. In the event of any conflict between the terms of the Intercreditor Agreement and this Intellectual Property Security Agreement, the terms of the Intercreditor Agreement shall govern and control.

Section 20 (Miscellaneous) of the Agreement is incorporated herein by this reference as though set forth in full.


