Assignor hereby authorizes and request the Director of Patents of the United States to issue patents or similar legal protection for said inventions to Assignee, the same to be held by Assignee for its own use and benefit, to the full end of the term for which said patents or similar legal protection are or may be granted, as fully and entirely as the same would have been held and enjoyed by Assignor had this assignment not been made.

This nunc pro tunc Assignment is effective as of September 6, 2013.



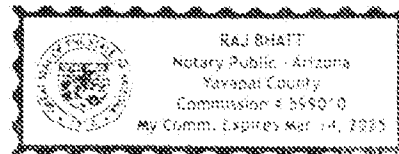
