ASSIGNMENT AGREEMENT

1. Assignment of Patents. Assignor hereby assigns, transfers, and conveys to Assignee, and Assignee hereby accepts from Assignor, the entire right, title, and interest throughout the world in and to the patents and patent applications listed on Exhibit A attached hereto ("*Patents*"), including, but not limited to, (a) all patents that may be granted from the Patents, (b) all divisions, continuations, continuations-in-part, reissues, reexaminations, renewals, continuing prosecution applications, and extensions of the Patents, (c) all rights of priority under International Conventions and applications for letters patent that may hereafter be filed for any of the foregoing in any country, (d) all foreign patents, patent applications and counterparts relating to any of the foregoing, including, without limitation, certificates of invention, utility models, industrial design protection, design patent protection, and other governmental grants or issuances. Assignor hereby authorizes and requests the respective patent office or governmental agency in each jurisdiction to issue any and all patents, design patents, certificates of invention, utility models, industrial designs, or other governmental grants or issuances that may be granted upon any of the Patents in the name of Assignee, as the assignee to the entire interest therein.

2. Assignment of Additional Patent Rights. Assignor hereby assigns, transfers, and conveys to Assignee, and Assignee hereby accepts from Assignor, all causes of action, all rights of enforcement, all claims for damages, and all remedies arising out of any violation of the rights assigned hereunder that may have accrued prior to the date of assignment to Assignee, or may accrue hereafter, including, but not limited to, the right to sue for, collect, and retain damages for past infringement of the Patents.
