MOBILITY ION TECHNOLOGIES S.L. of C/ El Juncal 3, 47195, Arroyo de la Encomienda (Valladolid), Spain, a company incorporated in Spain (hereinafter referred to as "the Assignee", which expression shall include its successors and assigns) of the other part.

WHEREAS

- A. The Assignor is the recorded owner of US patent no. 11,315,777 filed on 16 December 2019 (hereinafter referred to as "the Patent").
- B. The Assignor was placed into Creditors' Voluntary Liquidation on 30 March 2023 when the Liquidators were appointed liquidators.
- C. The Assignor has sold to the Assignee the Patent and the rights therein on 5 October 2023 and the Assignor accepts receipt of payment of the consideration for the Patent.
- D. The Assignor wishes to assign, to the extent that they have not already done so, to the Assignee any rights that they have in or to the Patent and confirm the transfer of the Patent to enable the Assignee to be recorded as the new owner of the Patent at the US Patent Offices.

NOW THIS ASSIGNMENT WITNESSETH THAT:

- 1. In consideration of the sum of one pound (£1) and other good and valuable consideration paid by Assignee to the Assignor, the receipt of which the Assignor hereby acknowledges, the Assignor hereby assigns to Assignee their entire right, title and interest in and to the Patent, and any patents, patent applications and like forms of protection (hereinafter collectively referred to as "the Patents and Patent


Applications") based on or derived from the Patent and including but not limited to any continuations, continuations-in-part, divisional applications, reissues, revalidations, registrations, inventors' certificates, petty patents, utility models, supplementary protection certificates and renewals and extensions thereof for all countries in the world,

2. At the request and reasonable cost of the Assignee, the Assignor shall execute all such documents and do all such acts as may be necessary or proper for enabling the Assignee to perfect its right, title and interest in and to the Patents and Patent Applications, and to prosecute, defend and enforce the Patents and Patent Applications, including but not limited to executing any application forms, confirmatory assignments, declarations, oaths, affidavits, technical reports and witness statements that may reasonably be required.
3. The Liquidators act as agents of the Assignor and without personal liability. They are a party to this Contract in their personal capacity solely to take the benefit of the exclusions of liability contained in it.
4. This Assignment may be executed in one or more counterparts, each of which shall be deemed an original and all of which may be taken together as one and the same Assignment.
5. This Assignment shall be governed by the laws of England and Wales and the parties to this Agreement agree to submit to the non-exclusive jurisdiction of the English Courts in respect of any matters arising out of it.


