ASSIGNMENT OF INVENTION AND PATENT RIGHTS

WHEREAS, Lisias Ransan, an individual and citizen of the United States of America residing at 4699 NW 26th Way, Boca Raton, Florida USA, 33434 ("Assignor"), is the sole inventor named in the U.S., foreign and international utility patents and design patents (collectively the "Patents"), patent applications (collectively the "Patent Applications") and utility models (collectively the "Utility Models") listed in attached Schedule A.

Teixeira de Araujo"), (Ballardini, V. Teixeira de Araujo and I. Teixeira de Araujo being referred to collectively hereinafter as the "Assignees", each of them individually an "Assignee").

WHEREAS, Assignor and each of the Assignees desire that Assignor and each of the Assignees shall each own an undivided one forth (1/4) interest in, to and under any and all worldwide rights, title and interest owned and/or held by Assignor prior to the Effective Date in, to and under the Patents, the Patent Applications, the Utility Models, all inventions, improvements and ornamental designs disclosed and/or claimed in any of the Patents, Patent Applications and Utility Models (said inventions, improvements and

ornamental designs hereinafter referred to collectively as the "Inventions") and all other subject matter identified in sub-clauses (i) through (xii) below of this instrument.


NOW, THEREFORE, in consideration of the sum of ten U.S. dollars (\$10.00) and other good and valuable consideration, the receipt, sufficiency and reasonably equivalent value of which is hereby acknowledged, and while hereby expressly and forever reserving unto Assignor, his heirs, executors, legal representatives and assigns a remaining undivided one forth (1/4) interest in, to and under the subject matter identified in sub-clauses (i) through (xii) below of this instrument, Assignor, on behalf of himself, his heirs, executors, legal representatives and assigns, hereby irrevocably sells, assigns, transfers and conveys to each Assignee and the respective, heirs, executors, legal representatives and assigns of each Assignee:

an undivided one forth (1/4) interest in, to and under any and all worldwide rights, title and interest owned and/or held by Assignor prior to the Effective Date of this instrument in, to and under:

(i) the Inventions, (ii) the Patents for the entire of the term of each respective one of the Patents; (iii) the Utility Models for the entire of the term of each respective one of the Utility Models; (iv) Patent Applications; (v) any and all patents which may issue at any time directly or indirectly from any of the Patent Applications for the entire of the term of each respective one of said patents; (vi) any and all existing and/or future reissues, re-examinations and extensions of any and all of the Patents and/or the Utility Models for the entire of the term of each respective one of said reissues, re-examinations and extensions; (vii) any and all existing and/or future reissues, re-examinations and extensions of any and all patents which may issue at any time directly or indirectly from any of the Patent Applications for the entire of the term of each respective one of said reissues, re-examinations and extensions (viii) any and all patent applications filed at any time which claim, or are amended to claim, any right of priority to or through any of the Patents, Patent Applications and/or Utility Models, including without limitation any and all divisionals, continuations and/or continuations-in-part thereof; (ix) any and all patents which issue at any time directly or indirectly from any of the patent applications referred to in sub-clause viii above, for the entire of the term of each respective one of said patents, (x) any and all existing and/or future reissues, re-examinations

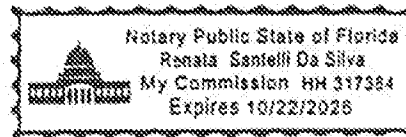

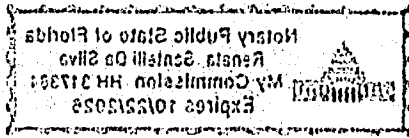
