PATENT ASSIGNMENT

This Patent Assignment, dated October 13, 2023, is made by Honeywell International Inc., a Delaware corporation having a place of business at 1944 E. Sky Harbor Circle North, Phoenix, AZ 85034, United States ("Assignor"), in favor of Hyundai Motor Company (including its affiliate, Kia Corporation), a company duly organized and validly existing under the laws of the Republic of Korea having a place of business at 12, Heolleung-ro, Seocho-gu, Seoul, 137938, Republic of Korea ("Assignee").

1. Assignment. Assignor is the owner of all right, title, and interest in U.S. Patent No. 11448136B2, Adaptive aircraft electrical power distribution system, issued September 20, 2022 and related pending European Application No. EP3895994A1 (collectively, "the '136 Patent"). (a) any and all rights of any kind whatsoever of Assignor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world;

(b) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(c) any and all claims and causes of action, with respect to any of the foregoing, whether accruing before, on and/or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Recordation and Further Actions. Assignor authorizes the Commissioner for Patents and any other governmental officials to record and register this assignment upon request by Assignee. Assignor shall take such steps and actions following the date hereof, including the execution of any documents, files, registrations, or other similar items, to ensure that the Assigned Patents are properly assigned to Assignee, or any assignee or successor thereto.

3. Form. A signed copy of this assignment delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this assignment.

4. Successors and Assigns. This assignment shall be binding upon and shall inure to the benefit of the parties hereto and to their respective successors and assigns.
