WHEREAS, the Security Agreement was recorded on August 5, 2019 with the United States Copyright Office at Volume 9985, Document 619 (the "Copyright Collateral").

WHEREAS, the Debtor has requested that the Secured Party release its security interest in and lien on the Trademark Collateral, the Patent Collateral and the Copyright Collateral (together "Intellectual Property Collateral") including but not limited to the Intellectual Property Collateral listed on attached Schedule A (the "Released Intellectual Property")

The Secured Party now wishes to release and terminate the security interest in the Released Intellectual Property.


THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party releases and terminates the Security Interest in the Released Intellectual Property.




