PATENT ASSIGNMENT

attorneys of Workman Nydegger to fill in the Serial Number and filing date when known), the aforementioned patent applications being collectively known herein as the "Patent Applications".

The right to file foreign patent applications on the Inventions in its own name, wherever such right may be legally exercised, including the right to claim the benefits of the International Convention for such applications.

Assignor hereby authorizes and requests the United States Commissioner of Patents and Trademarks and such Patent Office officials in foreign countries as are duly authorized by their patent laws to issue patents to issue any and all patents on the Inventions to Assignee as the owner of the entire interest, for the sole use of Assignee, its successors, assigns and legal representatives.

Assignor hereby agrees, without further consideration and without expense to Assignor, to sign all lawful papers and to perform all other lawful acts which Assignee may request of Assignor to make this Assignment fully effective, including, by way of example but not of limitation, the following:

Prompt execution of all original, divisional, continuation, continuation-in-part, substitute, reissue and other United States and foreign patent applications and assignment documents relating to the Inventions, and all lawful documents requested by Assignee to further the prosecution of any of such patent applications.

Cooperation to the best of Assignor's abilities in the execution of all lawful documents, the production of evidence, nullification, reissue, extension or infringement proceedings involving the Inventions.

This assignment and agreement is and will be binding upon our respective heirs and legal representatives. This assignment and agreement may be executed in separate counterparts, which, when combined, constitute the same agreement.
