ASSIGNMENT

WHEREAS, I, Robert S. Lowery, have jointly with Zigmond Robert Gustafson and Michael D. Kaczowski, invented certain new and useful improvements disclosed in U.S. Patent Application No. 17/668,703, entitled "Light Sensor Amblyopia Patch Device" and filed on February 10, 2022; and

WHEREAS, BioVentures, LLC, having an office at 4301 W. NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, I have sold, assigned, transferred and set over, and by these presents do sell, assign, transfer and set over unto BioVentures an undivided fifty percent (50%) interest of my right, title and interest in and to said improvements, said application, all applications for Letters Patent or Patents heretofore or hereafter filed for said improvements in the United States of America and in any foreign country (including related rights such as utility model registrations, inventor's certificates and the like), and all Letters Patent or Patents in the United States of America and all foreign countries which may be granted thereon, and in and to all substitutions, divisions, continuations and continuations-in-part of said United States or foreign applications, or renewals, extensions, reissues or reexaminations of said Letters Patent or Patents, and all rights under the International Convention for the Protection of Industrial Property, including all rights to claim priority, and further by these presents do sell, assign, transfer and set over unto ACRI an undivided fifty percent (50%) interest of my right, title and interest in and to said improvements, said application, all applications for Letters Patent or Patents heretofore or hereafter filed for said improvements in the United States of America and in any foreign country (including related rights such as utility model registrations, inventor's certificates and the like), and all Letters Patent or Patents in the United States of America and all foreign countries which may be granted thereon, and in and to all substitutions, divisions, continuations and continuations-in-part of said United States or foreign applications, or renewals, extensions, reissues or reexaminations of said Letters Patent or Patents, and all rights under the International Convention for the Protection of Industrial Property, including all rights to claim priority; and

I hereby covenant that I have the full right to convey the entire interest herein assigned and that no assignment, sale, agreement or encumbrance has been or will be entered into which would conflict with this assignment; and

I hereby covenant and agree that I will communicate to said Assignees any fact known to me respecting said improvements, sign all papers and documents, take all lawful oaths, and do all acts necessary or required to be done for the procurement, maintenance, enforcement and defense of Letters Patent or Patents for said improvements, without further consideration from said Assignees, but at the cost and expense of said Assignees; and

I hereby request the Director of the United States Patent and Trademark Office, and any officials of foreign countries whose duty it is to issue patents on applications as aforesaid, to issue said Letters Patent to said Assignees.
