

AND WE DO HEREBY sell, assign, transfer, and convey to ASSIGNEE, his successors, legal representatives, and assignees all claims for damages and all remedies arising out of any violation of the rights assigned hereby that may have accrued prior to the date of assignment to ASSIGNEE, or may accrue hereafter, including, but not limited to, the right to sue for, collect, and retain damages for past infringements of the said Letters Patent before or after issuance.

AND WE HEREBY covenant and agree that we/I will communicate to the said ASSIGNEE, its successors, legal representatives, and assignees, any facts known to us/me respecting said improvements, and testify in any legal proceeding, sign all lawful papers,

execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the said ASSIGNEE, its successors, legal representatives and assignees, to obtain and enforce proper patent protection for said improvements in all countries.
