Reference is made to (i) the U.S. Collateral Agreement, dated as of March 19, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “U.S. Collateral Agreement”), among MALLINCKRODT INTERNATIONAL FINANCE S.A., a public limited liability company (société anonyme) incorporated under the laws of the Grand Duchy of Luxembourg, having its registered office at 124, boulevard de la Pétrusse, L-2330 Luxembourg, and registered with the Luxembourg Trade and Companies Register (R.C.S Luxembourg) under number B 172.865 (the “Lux Borrower”), MALLINCKRODT CB LLC, a Delaware limited liability company (the “Co-Borrower”, and together with the Lux Borrower, the “Borrowers”), Mallinckrodt Finance GmbH (the “Swiss Finco”), each other Subsidiary Loan Party listed on the signature pages thereof and each other Subsidiary Loan Party that becomes a party thereto after the Closing Date (as defined therein) and DEUTSCHE BANK AG NEW YORK BRANCH, as collateral agent (together with its successors and assigns in such capacity, the “Collateral Agent”) for the Secured Parties (as defined therein) and (ii) the Notices of Grant of Security Interest in Patents, dated as of March 19, 2014, April 16, 2015, September 25, 2015, June 15, 2016, September 16, 2016, August 17, 2017, September 25, 2017, December 22, 2017, July 19, 2019, December 9, 2019, April 21, 2020 and August 25, 2023 among the Pledgors party thereto and the Collateral Agent (such documents set forth in clauses (i) and (ii) the “Security Documents”).

B. Pursuant to the Security Documents, the Pledgors granted to the Collateral Agent, for the benefit of the Secured Parties, a security interest in all right, title and interest of the Pledgors in, to and under, among other things, the Patents of the Pledgors set forth on Schedule I hereto (collectively, the “Patent Collateral”), which security interest was recorded with the United States Patent and Trademark Office on March 19, 2014 at Reel/Frame 032480/0001, on April 19,

2015 at Reel/Frame 035443/0241 and Reel/Frame 035454/0768, on September 25, 2015 at Reel/Frame 036662/0053, on July 1, 2016 at Reel/Frame 039237/0147, on September 16, 2016 at Reel/Frame 040059/0222, on August 18, 2017 at Reel/Frame 043596/0080, Reel/Frame 043601/0025, Reel/Frame 043596/0107, Reel/Frame 043596/0124, Reel/Frame 043596/0259 and Reel/Frame 043596/0277, on October 10, 2017 at Reel/Frame 044173/0574, on December 22, 2017 at Reel/Frame 044949/0634, on July 22, 2019 at Reel/Frame 049821/0425, Reel/Frame 049822/0674, Reel/Frame 049822/0829, Reel/Frame 049823/0213, Reel/Frame 049823/0220, Reel/Frame 049823/0233, Reel/Frame 049823/0301 and Reel/Frame 049823/0308, on December 9, 2019 at Reel/Frame 051231/0961, on April 21, 2020 at Reel/Frame 052456/0158, and on August 25, 2023 at Reel/Frame 064709/0055.

Accordingly, for good and valuable consideration, the receipt and sufficiency of the which are hereby acknowledged, in accordance with the U.S. Collateral Agreement, the Collateral Agent does hereby release, relinquish and discharge any and all security interests it has against the Patent Collateral. If and to the extent that the Collateral Agent has acquired any right, title or interest in and to the Patent Collateral, the Collateral Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the applicable Pledgor. The Collateral Agent acknowledges and agrees that the Issuers or their designees shall, on behalf of the Collateral Agent (at the Issuers' sole cost and expenses), make filings, including of this Release, with the United States Patent and Trademark Office and other necessary filings to evidence the release and termination of the Collateral Agent's security interests in the Patent Collateral. The Collateral Agent agrees to take all further actions, and provide to each Pledgor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Pledgors, at the Pledgors' sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK AND SHALL BE BINDING UPON THE COLLATERAL AGENT'S REPRESENTATIVES, SUCCESSORS, ASSIGNS AND TRANSFEREES.

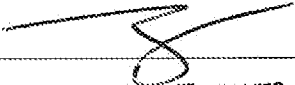

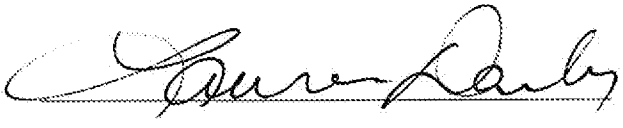
