Intellectual Property Assignment Agreement

This Intellectual Property Assignment Agreement ("Agreement") is made by and between altumAI Inc, a Delaware company ("altumAI") and altumAI Insurance Solutions LLC, a California company ("AIS"), with each referred to as a "Party" and collectively "the Parties." The Effective Date of this Agreement is the date of the last of the Parties to execute this Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

1. AIS hereby grants, transfers, assigns, and conveys to altumAI, its successors and assigns, the entire right, title, interest, ownership, goodwill, and all subsidiary rights in and to all Acquired Assets listed in Section 2.1 of the Asset Purchase Agreement including the Software and Intellectual Property set forth in the attached Schedule A, including but not limited to all patent, copyright, and trademark rights therein, including all rights in and to any patent for the entire term of the patent and any continuation, continuation-in-part, and divisional application therefrom, and any reissue or re-examination as to any patent, all goodwill in any trademarks, and the right to sue for and recover all damages and other remedies in respect of any infringement of the Software and Intellectual Property for any past, present and future infringements thereof.


