- BVG and BHC are hereinafter collectively referred to as "the Parties" -

The following employee of BVG (hereinafter referred to as the "INVENTOR") contributed to an invention with the internal title „*Multisensor System, Device and Method for Safeguarding the Wellbeing of Patients Before, During and After Contrast Media Injections*“, which is recorded under the internal reference numbers **BHC201042/BHC209016** (hereinafter referred to as „INVENTION“):

BVG claimed the rights of the INVENTOR in and to the INVENTION pursuant to § 6 ArbNErfG (German Employee Inventions Act).

BHC is interested in receiving from BVG BVG's rights in and to the INVENTION, and BVG is willing to assign such rights to BHC.

NOW, THEREFORE, the Parties agree as follows:

1. BVG hereby represents and warrants that it has obtained from the INVENTOR, INVENTOR's right, title and interest in and to the INVENTION.

2. BVG herewith assigns to BHC its right, title and interest in and to the INVENTION, including the right to file patent applications claiming the INVENTION in BHC's name in any country of the world and the right to claim priority of such patent applications for 1 USD (one U.S. Dollar) and other good and valuable consideration.

3. The Parties agree that this agreement and the assignment of the rights pursuant to Article 2 shall become retroactively effective on 2020-04-30.


4. Should one or more of the terms in this agreement be wholly or partly ineffective, this shall not affect the validity of the remaining terms. In such case, such term shall be replaced by another effective term approaching to the extent possible the economic purpose of the ineffective term.

5. The Parties may exchange executed copies of this agreement in portable document format (PDF) by electronic mail or other reasonable form of electronic transmission. PDF signatures of authorized signatories of the Parties shall be deemed to be original signatures, shall be valid and binding upon the Parties, and, upon delivery, shall constitute due execution of this agreement.



6. This agreement shall be construed and interpreted in accordance with and governed by the Substantive laws of Germany. The exclusive place of jurisdiction shall be Düsseldorf, Germany.
