
WHEREAS, Assignee desires to acquire an undivided interest in all such invention and Patent.

Assignor does hereby sell, assign, and transfer unto Assignee, and Assignee accepts, all its rights outside the United States in and to said invention and the Patent, including, without limitation, any continuation, divisional, reissue, reexamination, continuation-in-part, continuation, extension, and post-grant review thereof; including the right to claim priority to the Patent, and the right to file any subsequent patent application claiming priority to the Patent; and including all causes of action and enforcement rights for the Patent including all rights to pursue damages, injunctive relief, and other remedies for past and future infringement of the Patent.
3. Assignor hereby binds itself, its legal representatives, and assigns to execute without further consideration any and all applications, petitions, oaths, and assignments or other papers and instruments that may be necessary in order to perfect and carry into full force and effect the sale, assignment, and transfer hereby made or intended to be made.
4. Nothing in this assignment shall alter the rights and obligations of the Assignor and Assignee pursuant to separate agreements between the Parties.


