NUNC PRO TUNC ASSIGNMENT

2. The Inventor represents and warrants that I have the ability to convey all rights and interests herein assigned, that there are no rights or interests outstanding inconsistent with the rights and interests granted herein, and that I will not execute any instrument or grant or transfer any rights or interests inconsistent with the rights and interests granted herein.

3. The Inventor authorizes the Assignee to file for and request that the USPTO and corresponding bodies in each of the other Countries issue any and all patents resulting from any of the Applications to the Assignee.




