**RELEASE OF SECOND LIEN SECURITY INTEREST IN PATENTS**

This RELEASE OF SECOND LIEN SECURITY INTEREST IN PATENTS (this “Release”), dated as of December 1, 2023, is made by GOLDMAN SACHS BANK USA, as collateral agent for the Secured Parties (in such capacity, the “Agent”) in favor of JSONAR INC., a Delaware corporation (the “Grantor”). Capitalized terms used but not defined herein have the meanings given to them in the Patent Security Agreement (as defined below), whether defined directly therein or by reference to another agreement.

WHEREAS, pursuant to that certain Second Lien Security Agreement, dated as of January 10, 2019, by and between the Grantor, the Agent and certain other parties (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), the Grantor executed and delivered in favor of the Agent that certain Patent Security Agreement Supplement, dated as of January 29, 2021, which was recorded in the United States Patent and Trademark Office (“USPTO”) on January 31, 2021 at Reel/Frame 055188/0362 (the “Patent Security Agreement”);

WHEREAS, pursuant to the Security Agreement and the Patent Security Agreement, the Grantor granted to the Agent, for the ratable benefit of the Secured Parties, a security interest in all of the Grantor’s right, title and interest in and to the Additional Collateral (the “Security Interest”), including the patents and patent applications listed in Schedule I hereto; and

WHEREAS, the Grantor has requested that the Agent terminate and release its Security Interest in the Additional Collateral.

NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby absolutely, unconditionally and irrevocably (i) terminates and cancels the Patent Security Agreement, (ii) terminates, cancels, discharges and forever releases its Security Interest in the Additional Collateral and (iii) re-assigns to the Grantor any right, title or interest it may have in or to the Additional Collateral, in each case without recourse to the Agent and without representation or warranty of any kind.

The Grantor (and any successor to the Grantor, including any person or entity hereafter holding any right, title or interest in and to the Additional Collateral) is hereby authorized to record this Release with the USPTO, and in furtherance of the foregoing, the Agent hereto authorizes and requests the Commissioner for Patents of the United States of America and any other applicable government officer to record this Release against the Additional Collateral.

This Release shall be governed by and construed in accordance with the law of the State of New York.
