PATENT ASSIGNMENT

This PATENT ASSIGNMENT (this "Assignment"), effective as of June 30, 2023 (the "Effective Date"), is by and between ChampionX USA Inc., a Delaware corporation ("Assignor") and ChampionX LLC, a Delaware limited liability company ("Assignee"), (each a "Party" and collectively, the "Parties").

WHEREAS, Assignor has agreed to assign, transfer, and convey to Assignee all of Assignor's right, title, and interest in the patents and patent applications set forth on Schedule A hereto (the "Assigned Patents").

NOW, THEREFORE, in consideration of the foregoing and the covenants and agreements contained in this Assignment, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

1. Conveyance. Assignor hereby assigns, transfers and conveys to Assignee all of Assignor's right, title and interest in and to the Assigned Patents, together with any and all (a) related continuations, continuations-in-part, divisionals, reissues, reexaminations, substitutions, extensions, and foreign equivalents thereof and (b) priority rights derived from any of the Assigned Patents, or the items described in the foregoing subsection (a), by virtue of the International Convention for the Protection of Industrial Property and any other rights provided under applicable treaties or conventions, including rights in any and all provisional applications, together with all rights and remedies against past, present, and future infringement, misappropriation, or other violation thereof, including the right to enforce the foregoing and to sue for and recover profits and damages for any and all infringements, misappropriations, or other violations thereof, whether past, present or future, to the full end of the term or terms for which said patents may be granted, as fully and entirely as the same would have been held and enjoyed by Assignor without this assignment.

2. Recordation: Further Assurances. Assignor and Assignee shall each take any and all additional actions as may be reasonably necessary to effect the transactions contemplated hereby, including Assignor's execution of individual assignment documentation prepared by Assignee at Assignee's expense for filing with the authorities of each individual jurisdiction. Assignor and Assignee authorize and request that the United States Patent and Trademark Office and the corresponding entities or agencies in any applicable foreign jurisdictions, record Assignee as the assignee and owner of the Assigned Patents set forth on Schedule A and issue the patents from any pending applications included in the Assigned Patents to Assignee upon issuance or registration.

3. Successors and Assigns. The provisions of this Assignment and the obligations and rights hereunder shall be binding upon, inure to the benefit of and be enforceable by (and against) the Parties and their respective successors and permitted transferees and assigns.

4. Counterparts. This Assignment may be executed in more than one counterpart, all of which shall be considered one and the same agreement and shall become effective when one or more such counterparts have been signed by each of the Parties and delivered to each of the Parties.

5. Title and Headings. Titles and headings to sections herein are inserted for the convenience of reference only and are not intended to be a part of or to affect the meaning or interpretation of this Assignment.

6. Governing Law. This Assignment and any dispute arising out of, in connection with or relating to this Assignment shall be governed by and construed in accordance with the Laws of the State of Delaware, without giving effect to the conflicts of laws principles thereof.

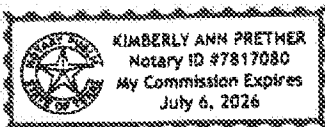

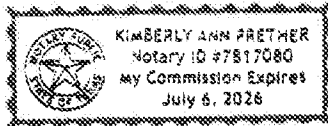
