## Intellectual Property Assignment Agreement

This Intellectual Property Assignment Agreement ("IP Assignment") is entered, by and between, DM Staton Family Limited Partnership, a Wyoming partnership, assignee of Staton Family Investments, Ltd., with an address of 6800 Broken Sound Parkway, Suite 200, Boca Raton, FL 33487 ("Staton") and Staton Techiya, LLC, a Delaware limited liability company with an address of 16193 Bridlewood Circle, Delray Beach, Florida 33445 (the "Company," and together with Staton, the "Parties").

### Recitals

A. Staton desires to convey, transfer, and assign to the Company, among other assets, certain intellectual property held by Staton, and have agreed to execute and deliver this IP Assignment, for recording with the United States Patent and Trademark Office and corresponding entities or agencies in any applicable jurisdictions;

B. The Parties agree as follows:

1. Assignment. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Staton hereby irrevocably conveys, transfers, and assigns to the Company, and the Company hereby accepts, all of Staton's right, title, and interest in and to all Staton's intellectual property that was previously owned by Personics Holdings, LLC and/or Personics Holdings, Inc., including the following (the "Assigned IP"):

(a) all inventions and discoveries (whether or not patentable or reduced to practice), improvements thereto, and invention disclosures, including the patents and patent applications set forth on Schedule 1 hereto and all issuances, divisions, continuations, continuations-in-part, reissues, extensions, reexaminations, and renewals thereof (the "Patents");

(b) all registered and common law trademarks, including the trademark registrations and applications set forth on Schedule 2 hereto and all issuances, extensions, and renewals thereof (the "Trademarks"), together with the goodwill of the business connected with the use of, and symbolized by, the Trademarks;

(c) all registered and unregistered copyrights, including the copyright registrations and applications for registration and all issuances, extensions, and renewals thereof (the "Copyrights");

(d) all domain names (the "Domains"), together with the goodwill of the business connected with the use of, and symbolized by, the Domains;

(e) all rights of any kind whatsoever of Staton accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world, including the right to claim for any applications the full benefits and priority rights of any international agreement between the United States and any foreign country or countries;

(f) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(g) any and all claims and causes of action, with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Recordation and Further Actions. Staton hereby authorizes the Commissioner for Patents and the Commissioner for Trademarks in the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this IP Assignment upon request by the Company. Following the date hereof, upon the Company's request, Staton shall take such steps and actions, and provide such cooperation and assistance to the Company and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be necessary to effect, evidence, or perfect the assignment of the Assigned IP to Staton, or any assignee or successor thereto.

3. Counterparts. This IP Assignment may be executed in one or more counterparts, each of which shall be deemed an original and all of which together shall constitute one and the same document and may be executed by means of facsimile, e-mail, or other forms of electronic signature. Signature pages may be detached from the counterparts and attached to a single copy of this IP Assignment to physically form one document.

4. Successors and Assigns. This IP Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.

5. Governing Law. The laws of the State of Florida, without giving effect to its conflicts of laws principles, shall govern all matters arising out of, in connection with, or relating to this Agreement including, without limitation, the validity, interpretation, construction, performance, and enforcement thereof.


