PATENT ASSIGNMENT

Assignor hereby transfers, conveys, assigns and delivers to Assignee all rights to prosecute the Patent Rights; all rights of priority in the Patent Rights in any country as may now or hereafter be granted by law, treaty or international convention; and all rights, interests, claims and demands recoverable in law, equity or otherwise, that Assignor has or may have in profits and damages for past, present, and future infringements of the Patent Rights, including, without limitation, the right to compromise, sue for and collect such profits and damages; the same to be held and enjoyed by Assignee, its successors and assigns or their legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made.



This appointment shall be deemed to be a power coupled with an interest, and as such, is irrevocable.
