WHEREAS, Nautilus, Inc., a corporation organized and existing under the laws of the State of Washington, and having its principal place of business at 17750 SE 6th Way, Vancouver, Washington 98683 US (the "Assignee"), desires to acquire any and all right, title, and interest of Assignor in and to the Invention, the IP Rights, and in and to any and all patents, design registrations, and other intellectual property registrations to be obtained therefor.

UPON SAID CONSIDERATION, the Assignor hereby covenants and agrees with the said Assignee that it will not execute any writing or do any act whatsoever conflicting with these presents, and that it will, at any time upon request, without further or additional consideration, but at the expense of the said Assignee, execute such additional assignments and other writings and do such additional acts as said Assignee may deem necessary or desirable to perfect the Assignee's enjoyment of this grant, and render all necessary assistance in making applications for and obtaining original, continuation, continuation-in-part, continuing prosecution, divisional, renewal, reissue, reexamined, or extended patents, design registrations, or other intellectual property registrations based on said Invention and IP Rights for any and all countries

and regions, and execute confirmatory assignments or acknowledgments of this Assignment as necessary for full enjoyment of the Invention and IP Rights and for recording in any patent or other office, and in enforcing any rights or choses in action accruing as a result of such Invention and IP Rights, by giving testimony in any proceedings or transactions involving such Invention and IP Rights, and by executing preliminary statements and other affidavits, it being understood that the foregoing covenant and agreement shall bind, and inure to the benefit of, the assigns and legal representatives of both parties;

UPON SAID CONSIDERATION, Assignor represents and warrants that Assignor has the right, title, and authority to execute this Assignment and to convey any and all right, title, and interest in the Invention and IP Rights, and that Assignor has not conveyed nor will convey hereafter all or part of the Invention and IP Rights to a third party; and






