ASSIGNOR hereby authorizes and requests the Commissioner of the United States Patent and Trademark Office to issue any and all Letters Patent for the Invention to Assignee and its respective successors and assigns, in accordance with the terms of this Assignment.

ASSIGNOR further agrees, without further consideration, (1) to execute and deliver all lawful papers and provisional, non-provisional, divisional, continuation, renewal, reexamination, and reissue applications, and substitute applications; (2) to execute and deliver all necessary assignment papers to cause any and all Letters Patent for the Invention to be issued to Assignee; (3) to testify in any legal proceeding; (4) to make all rightful oaths; and (5) generally to do everything reasonably possible to aid Assignee and its representatives to obtain and enforce proper protection for the Invention in the United States of America and in and all countries foreign thereto.

ASSIGNOR FURTHER hereby agrees that the terms, covenants, and conditions of this Assignment shall inure to the benefit of Assignee, its successors and assigns, and legal representatives, and shall be binding on Assignor, his legal representatives, successors, and assigns.
