This **PARTIAL RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY** (this “*Partial Release*”) is granted as of June 10, 2019 by **WILMINGTON TRUST, NATIONAL ASSOCIATION**, as administrative agent and collateral agent (the “*Grantee*”), in favor of **MARTHA STEWART LIVING OMNIMEDIA, INC.**, a Delaware corporation (“*MSLO*”), **MSO IP HOLDINGS, INC.**, a California corporation, **MARTHA STEWART, INC.**, a Connecticut corporation, **BODY & SOUL OMNIMEDIA, INC.**, a Delaware corporation, **MSLO PRODUCTIONS, INC.**, a Delaware corporation, **MSLO PRODUCTIONS – HOME, INC.**, a Delaware corporation, **MSLO PRODUCTIONS – EDF, INC.**, a Delaware corporation, **FLOUR PRODUCTIONS, INC.**, a Delaware corporation, a Delaware corporation, **MSLO SHARED IP SUB, LLC**, a Delaware limited liability company, **MSLO EMERIL ACQUISITION SUB, LLC**, a Delaware limited liability company, **EMERIL PRIMETIME MUSIC, INC.**, a Delaware corporation, **EMERIL PRIMETIME PRODUCTIONS, INC.**, a Delaware corporation, and **GOOD THINGS PRODUCTIONS, INC.**, a Delaware corporation (collectively, the “*Grantors*”);

WHEREAS, certain Grantors, among others, have executed and delivered (i) a Grant of Security Interest in United States Patents dated August 15, 2014 and recorded with the United States Patent and Trademark office on August 15, 2014 at Reel 33549, Frame 464 and (ii) a First Supplement to Grant of Security Interest in United States Patents dated September 11, 2015 and recorded with the United States Patent and Trademark office on September 11, 2015 at Reel 036544, Frame 0407, (iii) a Second Supplement to Grant of Security Interest in United States Patents dated December 4, 2015 and recorded with the United States Patent and Trademark office on February 1, 2016 at Reel 037664, Frame 0538, (iv) a Third Supplement to Grant of Security Interest in United States Patents dated July 1, 2016 and recorded with the United States

Patent and Trademark office on July 1, 2016 at Reel 039066, Frame 0639, and (v) a Fourth Supplement to Grant of Security Interest in United States Patents dated August 31, 2018 and recorded September 10, 2018 at Reel 046824, Frame 0862 (collectively, the “**Patent Agreement**”, and together with the Copyright Agreement and the Trademark Agreement, the “**Agreement**”). All capitalized terms used but not defined herein shall have the meanings set forth in the Agreement;

WHEREAS, MSLO is a wholly-owned subsidiary of Sequential Brands Group, Inc., a Delaware corporation (the “**Seller**”);

WHEREAS, the Seller has entered into that certain Equity Purchase Agreement, dated as of June 10, 2019 (the “**Purchase Agreement**”) with Marquee Brands LLC, a Delaware limited liability company, as the Buyer (the “**Buyer**”) pursuant to which, *inter alia*, the Seller has agreed to sell to the Buyer all of the issued and outstanding equity interests in MSLO; and

The Grantee hereby authorizes and requests that the USCO and USPTO note and record the present Partial Release.


