WHEREAS, pursuant to a Master Collaboration Agreement, dated May 22, 2009, between **ASSIGNOR** and **Agios Pharmaceuticals, Inc.**, a corporation organized and existing under the laws of the state of Delaware, and having an office for the transaction of business at 88 Sidney Street, Cambridge, MA 02139 (hereinafter "ASSIGNEE"), said ASSIGNOR has assigned, transferred, conveyed and set over unto said ASSIGNEE, its entire right, title and interest in, to and under the said invention and the said application.

NOW, THEREFORE, THIS CONFIRMATORY ASSIGNMENT HEREBY CONFIRMS that said ASSIGNOR, has sold, assigned, transferred and set over, and by these presents do hereby sell, assign, transfer and set over, effective prior to January 5, 2010, unto the said ASSIGNEE, its successors, legal representatives and assigns, its entire right, title and interest in, to and under the said invention, and the said United States provisional application and all applications claiming priority thereto under 35 U.S.C. § 119(e) and all divisions, renewals and continuations thereof, and all Patents of the United States which may be granted thereon and all reissues and extensions thereof; and all applications for industrial property protection, including, without limitation, all applications for patents, utility models, and designs which may be filed for said invention in any country or countries foreign to the United States, together with the right to file such applications and the right to claim for the same the priority rights derived from said United States application under the Patent Laws of the United States, the International Convention for the Protection of Industrial Property, or any other international agreement or the domestic laws of the country in which any such application is filed, as may be applicable; and all forms of industrial property protection, including, without limitation, patents, utility models, inventors' certificates and designs which may be granted for said invention in any country or countries foreign to the United States and all extensions, renewals and reissues thereof; and all right to sue for infringement including past infringement.

AND SAID ASSIGNOR HEREBY authorizes and requests the Commissioner for Patents and any Official of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to the said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.




