UPON SAID CONSIDERATIONS, Assignors hereby agree with the Assignee that Assignors will not execute any writing or do any act whatsoever conflicting with these presents, and that Assignors will, at any time upon request, without further or additional consideration but at the expense of the Assignee, execute such additional assignments and other writings and do such additional acts as the Assignee may deem necessary or desirable to perfect the Assignee's enjoyment of this grant, and render all necessary assistance in making application for and obtaining original, divisional, continuations, continuations-in-part, reexamined, reissued, or extended Letters Patent of the United States or of any and all foreign countries on the Invention, and in enforcing any rights in any action accruing as a result of such applications or patents, by giving testimony in any proceedings or transactions involving such applications or patents, and by executing preliminary statements and other affidavits, it being understood that the foregoing covenant and agreement shall bind, and inure to the benefit of the assigns and legal representatives of Assignors and Assignee;

AND Assignors request the Commissioner for Patents and Trademarks to issue any Letters Patent of the United States which may be issued for the Invention to the Assignee, its legal representatives, successors or assigns, as the sole owner of the entire right, title and interest in and to said patent and the Invention covered thereby.






