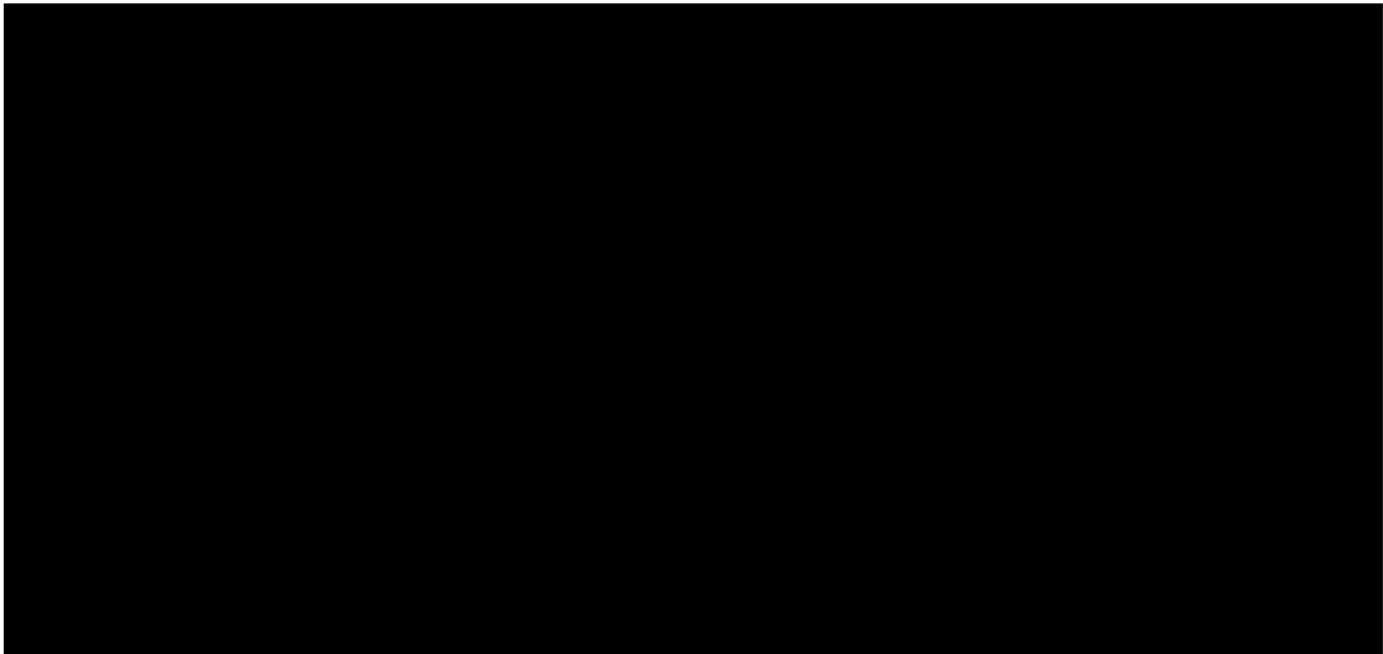


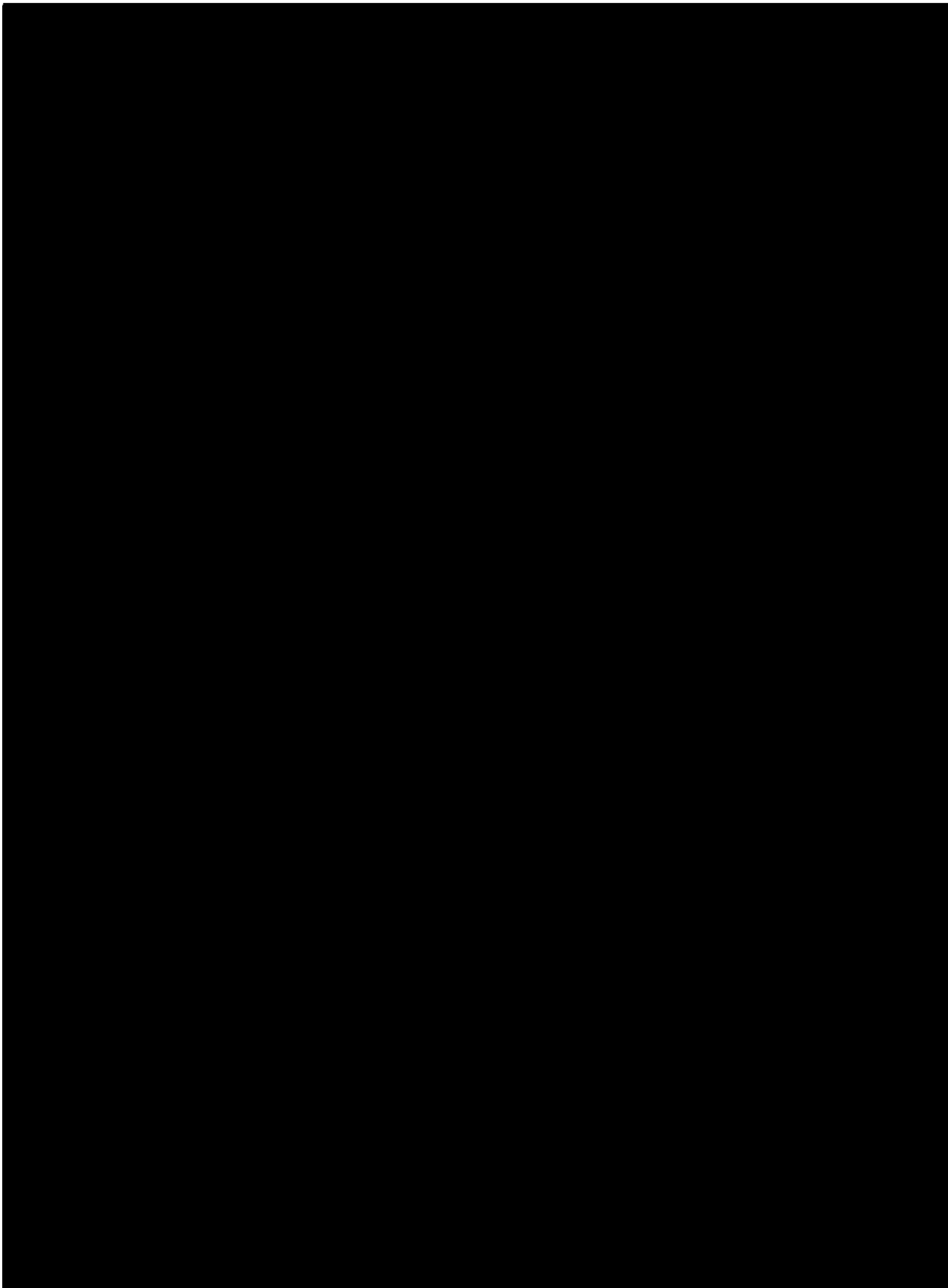


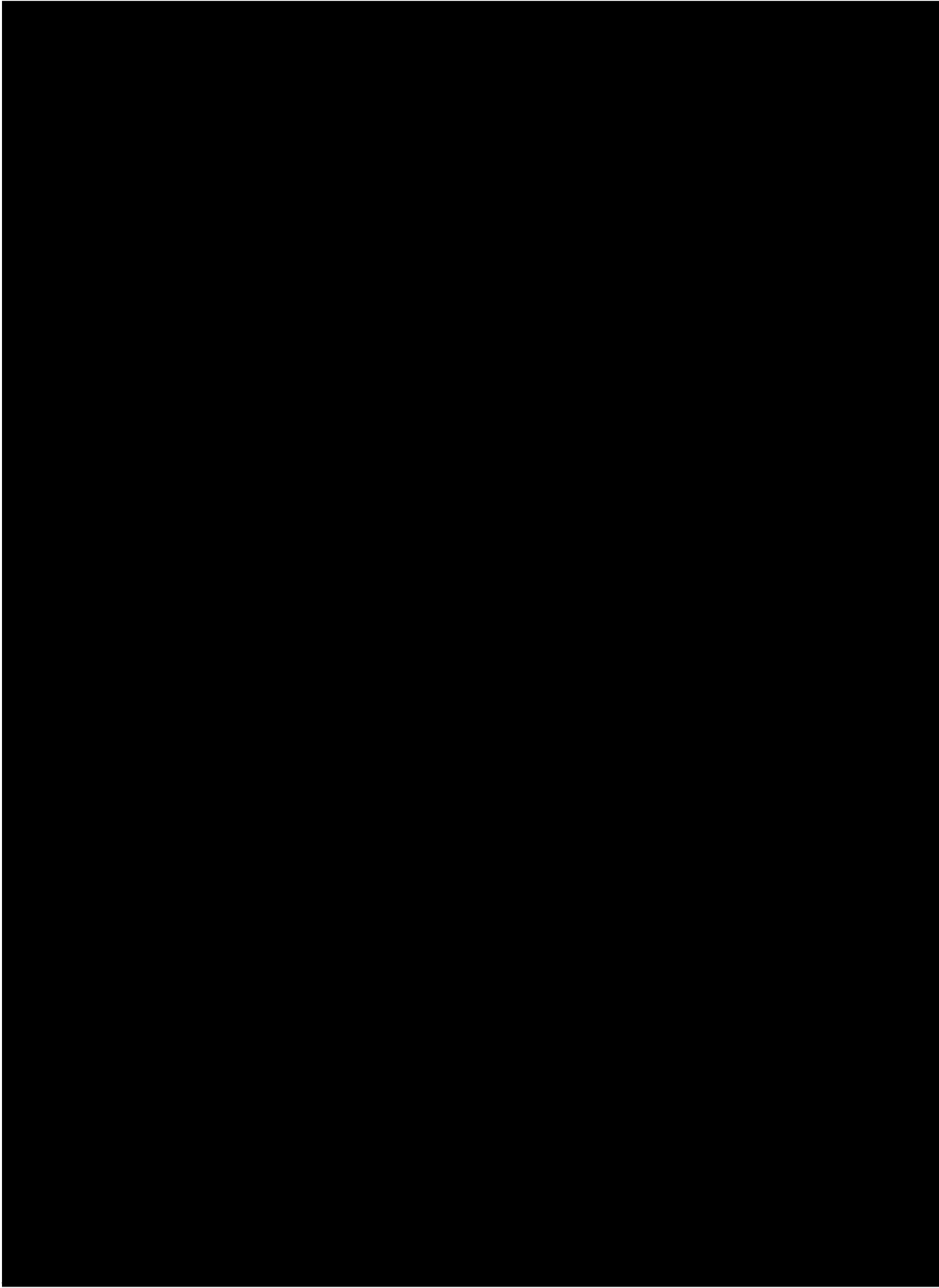


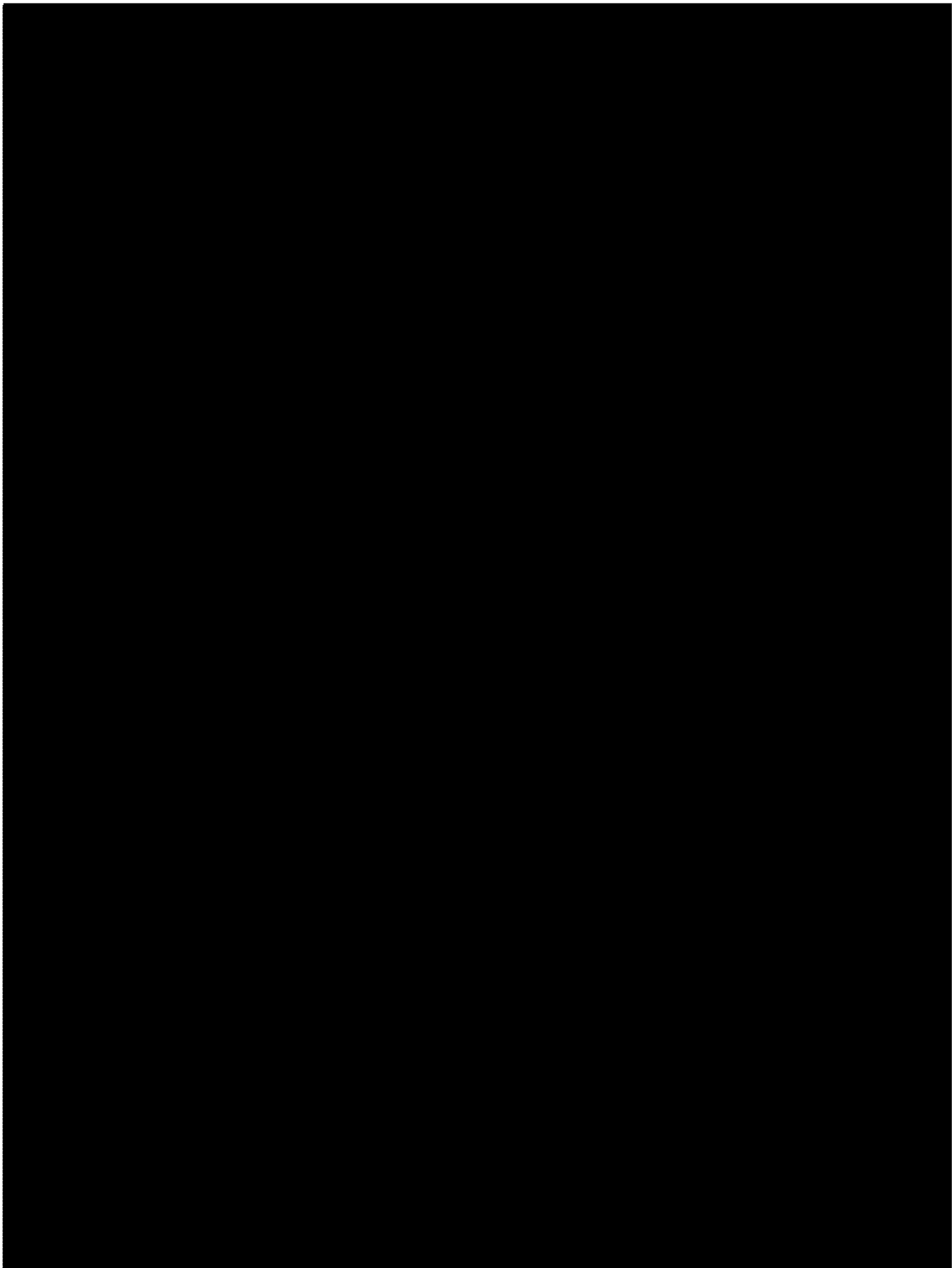
7. Ownership of Inventions.
