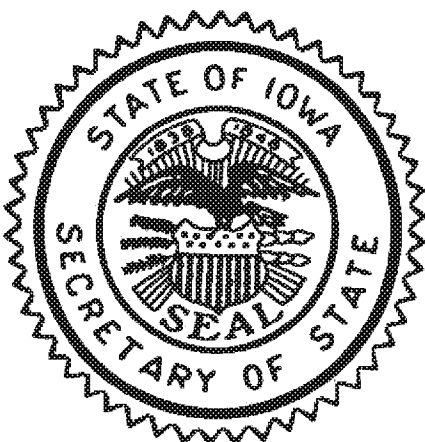

ARTICLES OF MERGER
of
APPLIED TD, INC.
with and into
SMART AG, INC.

October 31, 2019

These Articles of Merger (the "Articles of Merger"), prepared in accordance with Section 490.1106 of the Iowa Business Corporation Act, as amended ("IBCA"), relate to the merger of Applied TD, Inc., an Iowa corporation ("Merger Sub"), with and into Smart AG, Inc., an Iowa corporation and successor by conversion of Smart Ag, LLC (the "Company").

1. Plan of Merger. That certain Agreement and Plan of Merger (the "Plan of Merger"), dated as of the filing date hereof, by and among Raven Industries, Inc., a South Dakota corporation ("Parent"); Merger Sub, a wholly owned subsidiary of Parent; Company; and Fortis Advisors LLC, a Delaware limited liability company, has been approved by the board of directors of Merger Sub and the sole shareholder of Merger Sub, the board of directors of the Company, and the shareholders of the Company holding at least 90% of the issued and outstanding shares of Company capital stock, including 50% of Company preferred stock, in accordance with the Company's Articles of Incorporation and the IBCA.

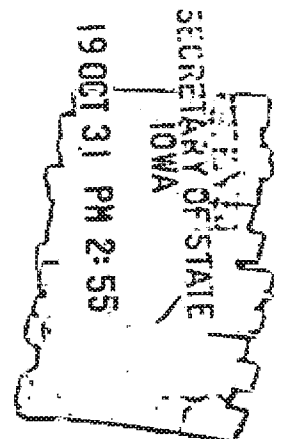
2. Parties to the Merger. Pursuant to the Plan of Merger, Parent, Merger Sub and the Company intend to effect a merger of Merger Sub with and into the Company (the "Merger"), and upon consummation of the Merger, Merger Sub will cease to exist, and the Company will become a wholly owned subsidiary of Parent.

3. Surviving Entity. The Company is the surviving entity and shall continue to exist as the surviving company under its present name pursuant to the provisions of the IBCA.

4. Articles of Incorporation of Surviving Entity. On the effective date of the Merger, the Articles of Incorporation of Merger Sub shall become the Articles of Incorporation of the Company (except that the Articles of Incorporation shall be amended to provide that the name of the surviving company will be "Smart Ag, Inc.").

5. Effective Date and Time of the Merger. The Merger shall be effective at 12:01 a.m. on November 1, 2019.

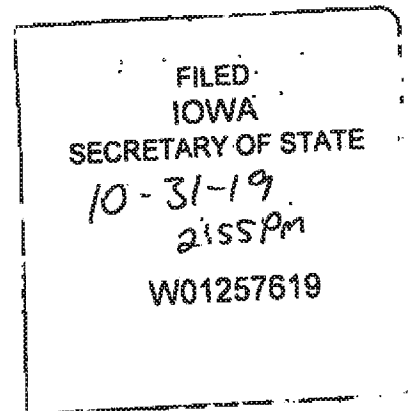
