TERMINATION OF SECURITY INTERESTS IN PATENTS

This Termination of Security Interests in Patents (this "Agreement") is made effective as of the 26 day of November 2023 by M&T Bank, a New York state-chartered banking corporation, with an office at 77 Pine Street, Burlington, Vermont 05401, and successor by merger to People's United Bank, National Association (the "Bank") and VERMONT SLATE & COPPER SERVICES INC., a Vermont corporation with its chief executive office and principal place of business at 289 Harrel Street, Morrisville, Vermont 05661 (the "Borrower").

WHEREAS, pursuant to the COLLATERAL ASSIGNMENT OF PATENTS, TRADEMARKS AND COPYRIGHTS and INTELLECTUAL PROPERTY SECURITY AGREEMENT dated as of April 1, 2021 by the Borrower in favor of the Bank, and recorded in the United States Department of Commerce, Patent and Trademark Office on April 1, 2021, with respect to Borrower at Reel/Frame: 055793/0454, the Borrower granted to the Bank a security interest in and lien on, and collaterally assigned to the Bank, all of its patents, patent registrations and associated goodwill, including, without limitation, the patents trademarks identified on Schedule A attached hereto (such trademarks referred to herein as the "Named Patents"); and

WHEREAS, the Bank has agreed to terminate its security interests in the Named Patents and quitclaim such security interests back to the Borrower.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are acknowledged, and intending to be legally bound hereby, the parties agree as follows:

The Bank hereby terminates its security interests in the Named Patents. The Bank hereby quitclaims and assigns to the Borrower, without recourse or representation or warranty, express or implied, all of the Bank's right, title and interest held by the Bank in the Named Patents, together with the goodwill symbolized thereby. The Borrower hereby accepts such assignment and acknowledges such assignment is without representation or warranty or liability on the part of the Bank.
