(vii) the right to claim for any patent or application the priority rights of or derived from the **Patent Properties** under the Patent Laws of the United States, the International Convention for the Protection of Industrial Property, the Patent Cooperation Treaty, any other international agreement, or the domestic laws of any country in which any such application is filed, as may be applicable;

(viii) all forms of intellectual property or industrial property protection, including, without limitation, patents, utility models, inventors' certificates, petty patents, design patents or similar legal protection that may be granted for the Invention(s) in any country or countries foreign to the United States and all extensions, renewals, and reissues thereof; and

(ix) any and all causes of action and enforcement rights, including all rights to sue, counterclaim, and recover for any past, present and future infringement of, or liabilities for, all Patent(s) utility models, inventors' certificates, petty patents, design patents or similar legal protection to be obtained for the inventions including but not limited to the **Patent Properties**;




