Assignor hereby represents and warrants to Assignee that it has the right, power and authority to make the within assignment, and that it has not executed any prior assignment.



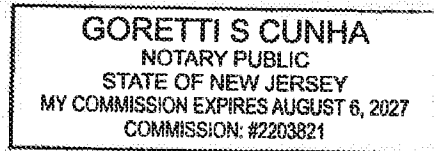
