TERMINATION AND RELEASE OF  
INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Termination and Release of Intellectual Property Security Agreement (this “Termination”) dated as of December 29, 2023, is executed by **RUNWAY GROWTH FINANCE CORP (F/K/A RUNWAY GROWTH CREDIT FUND INC.)** (the “Secured Party”), and in favor of **VERO BIOTECH INC. (F/K/A VERO BIOTECH LLC)**, a Delaware corporation (“Grantor”). All capitalized terms used in this Termination and not otherwise defined herein, shall have the respective meanings given to such terms in the Intellectual Property Security Agreement (defined below).

RECITALS

A. Pursuant to the Intellectual Property Security Agreement, dated as of December 29, 2020, executed by Grantor (as amended from time to time, the “Intellectual Property Security Agreement”), which was entered into in conjunction with that certain Loan and Security Agreement, dated as of December 29, 2020, between Secured Party and Grantor (as amended from time to time, the “Loan Agreement”), Grantor granted to Secured Party a security interest in the Intellectual Property (defined below).

B. The Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on October 3, 2022, at Reel/Frame 7149/0034 and Reel/Frame 054866/0589, to evidence the security interest granted under the Loan Agreement.

C. Secured Party agrees to terminate and release its security interest in the Intellectual Property specified below.

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby agrees as follows:

1. (a) The Intellectual Property Security Agreement and (b) with respect to the Intellectual Property, the Loan Agreement, are hereby terminated and of no further force and effect.

2. Secured Party hereby expressly irrevocably and unconditionally terminates, cancels, discharges and releases such security interest in all right, title and interest of Grantor in any and all Intellectual Property (as defined in the Intellectual Property Security Agreement), including, without limitation, all of the following and reassigns, transfers and conveys to Grantor any and all right, title and interest of Secured Party (if any) therein or thereto, including, in each instance, any and all of the foregoing granted to Secured Party pursuant to the Intellectual Property Security Agreement and/or Loan Agreement:

(a) copyright rights, copyright applications, copyright registrations and like protections in each work or authorship and derivative work thereof, whether published or unpublished, now or hereafter existing, created, acquired or held (collectively, the “Copyrights”), including the Copyrights described in **Exhibit A**;

(b) trademark and servicemark rights, whether registered or not, applications to register and registrations of the same and like protections, and the entire goodwill of the business of Grantor connected with and symbolized by such trademarks (collectively, the “Trademarks”), including the Trademarks described in **Exhibit B**;

(c) patents, patent applications and like protections including without limitation improvements, divisions, continuations, renewals, reissues, extensions and continuations-in-part of the same (collectively, the “Patents”), including the Patents described in **Exhibit C**;

(d) any and all trade secrets and trade secret rights, including, without limitation, any rights to unpatented inventions, know-how, operating manuals;


- (e) any and all source code;
  - (f) any and all design rights which may be available to Grantor;
  - (g) any and all claims for damages by way of past, present and future infringement of any of the foregoing, with the right, but not the obligation, to sue for and collect such damages for said use or infringement of the Intellectual Property rights identified above;
  - (h) all amendments, renewals and extensions of any of the Copyrights, Trademarks or Patents.
3. Secured Party represents and warrants that it has the full power and authority to execute this Termination.
4. Secured Party shall record or file this Termination with the United States Patent and Trademark Office (at the Grantor's sole cost and expense).
5. Secured Party hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the termination, release, or reassignment to the Grantor of the security interest contemplated hereby (at the Grantor's sole cost and expense).
