SECOND: The corporation hereby amends its Amended and Restated Certificate of Incorporation as follows:

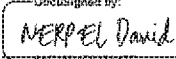
Article FIRST of the Amended and Restated Certificate of Incorporation, relating to the corporate name of the corporation, is hereby amended to read, in its entirety, as follows:
