Assignor also agrees to not sign any writing or do any act conflicting with this assignment, and, without further compensation, sign all documents and do such additional acts as Assignee deems necessary or desirable to: perfect Assignee’s enjoyment of the Inventions and rights hereunder acquired; conduct proceedings regarding the Inventions and the rights hereunder acquired, including any litigation or interference proceedings; or perfect or defend title to the Inventions and the rights hereunder acquired.

In addition, Assignor also assigns to Assignee exclusively throughout the world all of Assignor’s right, title, and interest (choate or inchoate) in and to (a) all ideas, inventions, concepts, business plans, and related work associated with the business idea for which the Assignee has been formed, (b) all work previously developed or produced in connection with the development of the Assignee’s business, (c) all precursors, portions, and work in progress with respect thereto and all inventions, works of authorship, technology, information, know-how, techniques, concepts, ideas, materials, and tools relating thereto or to the development, support, or maintenance thereof, and (d) all copyrights, patent rights (including, without limitation, the Inventions), trade secret

rights, trademark rights, mask works rights, sui generis database rights, and all other intellectual and industrial property rights of any sort and all business, contract rights, causes of action, and goodwill in, incorporated or embodied in, used to develop, or related to any of the foregoing.
