SUPPLEMENT NO. 1 TO INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Supplement No. 1 to Intellectual Property Security Agreement (this “*Supplement No. 1*”) is made as of the 12th day of January, 2024, by **o9 SOLUTIONS, INC.**, a Texas corporation (the “*Grantor*”), in favor of **JPMORGAN CHASE BANK, N.A.** (“*Lender*”).

WHEREAS, the Grantor executed and delivered an Intellectual Property Security Agreement dated as of August 19, 2022 (as amended and of record from time to time hereinafter, the “*Agreement*”) in favor of the Lender, pursuant to which the Grantor granted a security interest in certain Copyrights, Trademarks, Patents and Mask Works (collectively, the “*Intellectual Property Collateral*”). Capitalized terms not otherwise defined herein shall have the meaning set forth in the Agreement;

WHEREAS, the Agreement was recorded on (i) August 22, 2022 at Reel 7828, Frame 0681 in the Trademark division of the U.S. Patent and Trademark Office; and (ii) August 22, 2022 at Reel 060855, Frame 0934 in the Patent division of the U.S. Patent and Trademark Office; and

WHEREAS the Grantor desires to confirm the grant of a security interest in certain additional Intellectual Property Collateral in favor of the Lender.

NOW, THEREFORE, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:


1. Definitions. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the Agreement.
