WHEREAS, I am the assignor of the right, title and interest in and to the invention which shall be referred to as the "Inventive Subject-Matter" in this Assignment; and



continuation, or divisional application, renewal, reissued or extended Letters Patent of the United States, or of any and all foreign countries, on said Inventive Subject-Matter, and in enforcing any rights or chose in action accruing as a result of such applications or patents, by giving testimony in any proceedings or transactions involving such applications or patents, and by executing preliminary statements and other affidavits, it being understood that the foregoing covenant and agreement shall bind, and inure to the benefit of, the assigns and legal representatives of all parties.


