Now, therefore, for good and valuable consideration, the receipt of which is hereby acknowledged, as of the signing date, Seller hereby irrevocably sells, conveys, transfers, assigns and delivers to Purchaser, and Purchaser acquires from Seller, all right, title and interest in and to (i) all Assigned Patents and all rights to inventions as and to the extent claimed therein, (ii) all rights of priority and all claims, causes of action and enforcement rights of any kind and all rights to sue for past, present or future infringement of any of the Assigned Patents and to collect and retain any and all royalties, license fees, damages, costs, profits, compensation, equitable relief, injunctive relief and all other amounts and remedies for or relating to any such past, present or future infringement of the Assigned Patents or any and all claims relating thereto, and entirely stand in the place of Seller in all matters related to the Assigned Patents (iii) all rights to collect royalties, license fees or other amounts with respect to the Assigned Patents, and (iv) all rights to apply for, file, register, maintain, prosecute, extend, renew, enforce, license and otherwise exploit in any or all countries and regions of the world the Assigned Patents, and to claim priority based on the filing dates of any of the Assigned Patents under the International Convention for the Protection of Industrial Property, the Patent Cooperation Treaty, the European Patent Convention, the Paris Convention, and all other treaties of like purposes, in each case of (i), (ii), (iii), and (iv), without any requirement for Purchaser to seek or obtain any consent or other approval from or otherwise inform Seller (collectively, the "Assigned Patent Rights").

Seller does hereby authorize and request the respective patent office or governmental agency or authority in each jurisdiction, worldwide, to issue any and all future patents, certificates

of invention, utility models or other governmental grants or issuances that may be granted upon any of the Assigned Patent Rights in the name of Purchaser, as the assignee to the entire interest therein. This Assignment of Patent Rights will inure for the benefit of any permitted successors or assigns of Purchaser.




