TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENTS

THIS TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENTS (this "<u>Termination</u>") is dated as of December 29, 2023, and made by ACF FINCO I LP, a Delaware limited partnership, in its capacity as agent for each member of the Lender Group (in such capacity, together with its successors and assigns in such capacity, "<u>Agent</u>") to PLAYMONSTER GROUP LLC, a Delaware limited liability company ("<u>Grantor</u>").

RECITALS

WHEREAS, pursuant to (i) that certain Patent Security Agreement dated as of June 24, 2023, made by the Grantor in favor of the Agent (the "Patent Security Agreement"), (ii) that certain Trademark Security Agreement dated as of June 24, 2023, made by the Grantor in favor of the Agent (the "Trademark Security Agreement"), and (iii) that certain Copyright Security Agreement dated as of June 24, 2023, made by the Grantor in favor of the Agent (the "Copyright Security Agreement"; and together with the Patent Security Agreement and the Trademark Security Agreement, the "Security Agreements" and each a "Security Agreement"), the Grantor granted a security interest in favor of the Agent in and to all of the Grantor's right, title and interest in and to the Intellectual Property (defined below);

WHEREAS, (i) the Patent Security Agreement was recorded with the United States Patent and Trademark Office on July 1, 2023, at Reel 60562 and Frame 0484, and (ii) the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on June 29, 2023, at Reel 7765 and Frame 0880; and

WHEREAS, Agent now desires to terminate and release the Patent Security Agreement, the Trademark Security Agreement and the Copyright Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Agent hereby states as follows:

- 1. <u>Definitions</u>. Unless otherwise defined herein, the capitalized terms used herein which are defined in the Security Agreements shall have the meanings specified in the applicable Security Agreement. As used herein, the term "<u>Intellectual Property</u>" shall mean (i) Trademark registration and Trademark applications constituting "Trademark Collateral" as defined in the Trademark Security Agreement, including those listed on <u>Schedule 1</u> attached hereto, (ii) Patent registrations and Patent applications constituting "Patent Collateral" as defined in the Patent Security Agreement, including those listed on <u>Schedule 2</u> attached hereto, and (iii) Copyright registrations and Copyright applications constituting "Copyright Collateral" as defined in the Copyright Security Agreement, including those listed on Schedule 3 attached hereto.
- 2. <u>Release of Security Interest</u>. Agent hereby terminates the Patent Security Agreement, the Trademark Security Agreement and the Copyright Security Agreement and hereby absolutely and unconditionally terminates, releases, reconveys and forever discharges its security interest and any other interest it has in the Intellectual Property. Agent further absolutely and

unconditionally releases all of its right, title and interest in and to any and all property, assets and collateral secured, hypothecated or pledged under or by the Security Agreements.

3. <u>Further Assurances</u>. Agent shall take all reasonable action, and provide to the Grantor and its successors, assigns or other legal representatives all such reasonable cooperation and assistance, reasonably requested by the Grantor to more fully and effectively effectuate the purposes of this Termination, in any case, at the sole expense of the Grantor.
