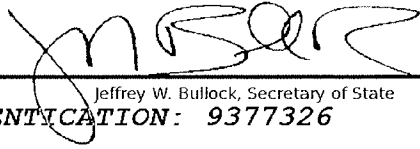

**CERTIFICATE OF AMENDMENT
OF
AMENDED AND RESTATED CERTIFICATE OF INCORPORATION
OF
XTONE, INC.**

XTONE, INC., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "**DGCL**"), does hereby certify:

ONE: The name of the corporation is **Xtone, Inc.** (the "**Company**").

TWO: The original name of this corporation is **Xtone Networks, Inc.** and the date of filing the original Certificate of Incorporation of this corporation with the Secretary of State of the State of Delaware is July 1, 2004.

THREE: The Board of Directors of the Company, acting in accordance with the provisions of Sections 141 and 242 of the DGCL, adopted resolutions approving the following amendments to the Company's Amended and Restated Certificate of Incorporation:

1. Article IV. A of the Company's Amended and Restated Certificate of Incorporation is hereby amended and restated in its entirety to read as follows:

"A. The Company is authorized to issue two classes of stock to be designated, respectively, "**Common Stock**" and "**Preferred Stock**." The total number of shares which the Company is authorized to issue is 99,200,000 shares, 58,100,000 shares of which shall be Common Stock (the "**Common Stock**") and 41,100,000 shares of which shall be Preferred Stock (the "**Preferred Stock**"). The Preferred Stock shall have a par value of \$0.0001 per share and the Common Stock shall have a par value of \$0.0001 per share."

2. Article IV. C of the Company's Amended and Restated Certificate of Incorporation is hereby amended and restated in its entirety to read as follows:

"C. 5,000,000 of the authorized shares of Preferred Stock are hereby designated "**Series A Preferred Stock**", 8,500,000 of the authorized shares of Preferred Stock are hereby designated "**Series A-1 Preferred Stock**", 18,000,000 of the authorized shares of Preferred Stock are hereby designated "**Series B Preferred Stock**" and 9,600,000 of the authorized shares of Preferred Stock are hereby designated "**Series B-1 Preferred Stock**" and together with the Series A Preferred Stock, the Series A-1 Preferred Stock and the Series B Preferred Stock, the "**Series Preferred**."

FOUR: This Certificate of Amendment of Amended and Restated Certificate of Incorporation herein certified has been duly adopted in accordance with the provisions of Sections 228 and 242 of the General Corporation Law of the State of Delaware.
