

CERCACOR LABS EMPLOYEE CONFIDENTIALITY AGREEMENT
(United States)

As an employee of Cercacor Laboratories, Inc, a Delaware corporation ("Cercacor") and in consideration of the compensation and benefits from my employment, I enter into to this Cercacor Employee Confidentiality Agreement (the "Agreement") with Cercacor and agree as follows:

6. I agree that I will promptly disclose in writing to Cercacor all discoveries, developments, designs, ideas, improvements, inventions, formulas, processes, techniques, know-how, and data works of authorship, (whether or not patentable or registrable under copyright or similar statutes) made, conceived, reduced to practice, or learned by me (either alone or jointly with others) during my employment with Cercacor, that are related to or useful in the business of Cercacor, or which result



from tasks assigned to me by Cercacor, or from the use of premises owned, leased, or otherwise acquired by Cercacor. For the purposes of this Agreement, all of the foregoing are referred to as Inventions.

7. I acknowledge and agree that all Inventions other than those listed in Exhibit A belong to and shall be the sole property of Cercacor and shall be Inventions of Cercacor subject to the provisions of this Agreement. I agree to assign and hereby assign to Cercacor all rights that I may have to such Inventions, except for inventions which I am allowed to retain under California Labor Code section 2870, a copy of which is attached to this Agreement as Exhibit B.

8. I agree that all works of authorship to which I contribute during my employment shall be considered "works made for hire" and shall be the sole property of Cercacor.

9. I will keep adequate records of all Inventions to which I contribute during my employment, and will make such records available to Cercacor on request.

10. I will cooperate with Cercacor and do whatever is necessary or appropriate to obtain patents, copyrights, or other legal protection on projects to which I contribute, and, if I am incapacitated for any reason from doing so, I hereby authorize Cercacor to act as my agent and to take whatever action is needed on my part to carry out this Agreement.


