- C. In the premises, the Assignor and Assignee have agreed to execute this Deed of Assignment.

1. ASSIGNMENT

For the sum of Ten Dollars Australian currency (AU\$10.00), and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by the Assignor, the Assignor hereby sells, assigns, transfers and makes over to the Assignee all such right, title and interest as the Assignor may have in and to the Inventions, including the entitlement to the grant of a patents for the Inventions, together with the right to make applications for patents, including divisional, additional, continuation and reissue applications, and obtain patents on any such applications, the right to claim Convention priority or any other priority rights in relation to any such applications, and the right to make applications for and obtain any other form of legal protection, in respect of the Inventions, in any jurisdiction, as the Assignee desires, and including the right to sue for, and receive damages or an account of profits for all past and future infringements of any patent or any other form of legal protection obtained for the Inventions.

2. POWER OF ATTORNEY






