NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN: Be it known that in consideration of the payment by ASSIGNEE of valuable consideration to ASSIGNOR, the receipt and adequacy of which is hereby acknowledged, and for other good and valuable consideration, ASSIGNOR hereby sells, assigns, transfers, conveys and delivers and agrees to sell, assign, transfer, convey and deliver to ASSIGNEE and the successors, assigns and legal representatives of the ASSIGNEE, all of ASSIGNORS' rights, title and interest, for the United States of America, in and to and under said Application and said inventions and improvements covered thereby along with any and all patent applications, and registrations therefor, and all improvements, divisionals, continuations, continuations-in-part, reissues, reexaminations, substitutions, extensions or renewals thereof, that have been filed or granted in the United States, its territorial possessions and/or any foreign countries for said inventions, and all rights, together with all priority rights, under any of the international conventions, unions, agreements, acts, and treaties, including all future conventions, unions, agreements, acts, and treaties, and all the rights and privileges under any and all forms of protection, including Letters Patent, that may be granted in said countries foreign to the United States for said inventions.

ASSIGNORS request that any and all patents for said inventions or improvements be issued to said ASSIGNEE, its successors, assigns and legal representatives, or to such nominees as it may designate.
