RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN CERTAIN INTELLECTUAL PROPERTY (the “Release”), dated as of January 22, 2024, is made by JPMORGAN CHASE BANK, N.A., having a place of business at 10 South Dearborn, Floor L2, Suite IL 1-0480 (“Lender”) in favor of WALBRO LLC, a Delaware limited liability company, having a place of business at 1320 Old Chain Bridge Road, Suite 400, McLean, Virginia 22101 (the “Grantor”). Capitalized terms used but not otherwise defined herein shall have the meanings given to them in the Credit Agreement or the Security Agreement (as those terms are defined below).

WHEREAS, Grantor and Lender are parties to a Pledge and Security Agreement dated as of October 27, 2021 (either as amended, supplemented or otherwise modified, renewed or replaced from time to time, the “Security Agreement”);

WHEREAS, Grantor and Lender are parties to a (i) Notice of Grant of Security Interest in Trademarks, dated as of October 27, 2021, recorded with the United States Patent and Trademark Office (“USPTO”) on November 8, 2021 at Reel 7487, Frame 0830 (the “Notice of Grant in Trademarks”), (ii) Notice of Grant of Security Interest in Patents, dated as of October 27, 2021, recorded with the USPTO on November 8, 2021 at Reel 058055, Frame 0101, and (iii) Notice of Grant of Security Interest in Patents, dated as of October 27, 2021, recorded with the USPTO on January 6, 2023 at Reel 062303, Frame 0709 (collectively, the “Notice of Grant in Patents”, and together with the Notice of Grant in Trademarks, collectively, the “Notice of Grant”);

WHEREAS, pursuant to the Security Agreement, the Grantor granted to Lender a continuing security interest in, and a right of set off against (the “Security Interest”) (i) the trademarks and trademark applications referred to on Schedule 1 attached to the Notice of Grant in Trademarks (the “Trademark Collateral”), and (ii) the patents and patent applications referred to on Schedule 1 attached to the Notice of Grant in Patents (the “Patent Collateral”), notice of which was provided in the USPTO pursuant to the Notice of Grant; and

WHEREAS, Lender has agreed to terminate and release the Security Interest in certain Trademark Collateral referred to on Schedule A attached hereto and certain Patent Collateral referred to on Schedule B attached hereto (collectively, the “Released Collateral”).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Release of Lien. Lender hereby terminates, extinguishes, cancels, releases and discharges the Security Interest in the Released Collateral, and assigns, discharges, quit claims and relinquishes unto Grantor any and all right, title and interest it has in and to the Released Collateral. The Grantor, and any successor to the Grantor (including any person or entity hereafter holding any right, title or interest in and to the Released Collateral) is hereby authorized to record this Release in the USPTO.

2. Further Assurances. Lender shall take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, such cooperation and assistance (including, without limitation, the execution and delivery of any documents or other instruments), reasonably requested by the Grantor, and at Grantor’s cost and expense, to more fully and effectively effectuate the release of liens contemplated hereby.

3. Governing Law. This Release shall be construed in accordance with and governed by the laws of the State of New York, without regard to principles of conflicts of laws requiring application of the law of any other jurisdiction.
