NOTICE OF RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

WHEREAS POWER STANDARDS LAB, INC., having a registered address at 980 Atlantic Avenue, Alameda, California, United States of America 94501 ("**Grantor**"), and **PLACEMENT SYLVAIN LANOUE INC. ("**Secured Party**")** entered into a General Security Agreement ("**GSA**"), pursuant to which Grantor granted to Secured Party a security interest in all of the intellectual property of the Grantor, whether then existing or thereafter acquired (the "**Intellectual Property Collateral**") in consideration for the provision of certain credit facilities to Grantor;

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by Secured Party, Secured Party agrees as follows:

1. Secured Party hereby unconditionally relinquishes, releases and terminates any and all of its right, title and interest in and to any and all liens and security interests the Secured Party may have had upon the Intellectual Property Collateral, including without limitation, upon the Copyrights, Trademarks, Patents and Mask Works, pursuant to the GSA.
2. Secured Party hereby authorizes Grantor or any of its authorized representatives to file this Release of Security Interest (the "**Release**") with the USPTO or any other applicable governmental office, and Secured Party authorizes and requests that the USPTO and any other applicable governmental office record this Release in respect of the Intellectual Property Collateral, including the Copyrights, Trademarks, Patents and Industrial Design.
3. This Release is executed in accordance with and is subject to, governed by and interpreted in accordance with the applicable laws of the United States of America and the State of New York.
4. This Release shall be effective upon execution and shall be binding upon the Secured Party's legal representatives, assigns and successors.
