RELEASE OF PATENT SECURITY INTEREST

This **RELEASE OF PATENT SECURITY INTEREST** (this "Release") is made as of January 29, 2024, by **ANKURA TRUST COMPANY, LLC**, in its capacity as administrative agent (the "Administrative Agent") for the benefit of **VELOCITY TECHNOLOGY SOLUTIONS, INC.**, a Delaware corporation, and **NAVISITE LLC**, a Delaware limited liability company (each a "Grantor" and collectively, the "Grantors"). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement (as defined below), or the Patent Security Agreement (as defined below) or as applicable.

<u>WITNESSETH</u>:

WHEREAS, the Grantors and the Administrative Agent are parties to that certain (i) Second Lien Security Agreement, dated as of December 30, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"); and (ii) Patent Security Agreement, dated as of December 30, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Patent Security Agreement"), pursuant to which the Grantors have granted to the Administrative Agent for the benefit of the Secured Parties a lien on and security interest in all of the right, title and interest of the Grantors in, to and under the Patent Collateral (as defined in the Patent Security Agreement), including the patents set forth on Schedule A; and

WHEREAS, the Patent Security Agreement was recorded in the United States Patent and Trademark Office on January 12, 2021 at Reel 054892 and Frame 0971; and

WHEREAS, the Grantors have requested that the Administrative Agent release, and the Administrative Agent is willing to release its lien on and security interest in, and any other right, title, and interest it may have in, to and under the Patent Collateral, including, without limitation, the patents set forth on <u>Schedule A</u> hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:

- 1. The Administrative Agent does hereby irrevocably terminate, release and discharge the entirety of any and all liens or security interests that it may have in, and all claims, whether presently existing or hereafter acquired or created, pursuant to the Security Agreement or Patent Security Agreement to the Patent Collateral, including, without limitation, the patents (including the patent registrations and patent applications) set forth on Schedule A hereto, and all proceeds thereof, and any right, title or interest of the Administrative Agent in such Patent Collateral shall hereby terminate, cease and become void. The Administrative Agent hereby assigns, transfers and conveys any and all right, title or interest of the Administrative Agent in the Patent Collateral to the Grantors.
- 2. The Administrative Agent, on behalf of itself and the Secured Parties, does hereby terminate and cancel the Patent Security Agreement.

- 3. The Administrative Agent hereby authorizes the Grantors or the Grantors' authorized representative to (i) record this Release with the USPTO, (ii) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the security interest of the Administrative Agent in the Patent Collateral and/or (iii) otherwise record or file this Release in the applicable governmental office or agency. The Administrative Agent further agrees to execute and deliver to the Grantors any and all further documents and instruments prepared by the Grantors, and do any and all further acts which the Grantors (or its agents or designees) reasonably request (at the Grantors' sole cost and expense) in order to confirm this Release and the Grantors' right, title and interest in, to and under the Patent Collateral.
- 4. This Release may be executed in any number of counterparts (including electronic transmission and facsimile counterparts), each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument.
- 5. This Release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York.
