



CONFIRMATORY DEED OF ASSIGNMENT

This **Confirmatory Deed of Assignment (“Confirmatory Deed of Assignment”)** dated September 21, 2020 2020 is between:

**Baxter Innovation & Business Solutions Private limited** (hereinafter referred to as ‘Baxter; which expression shall include its successors and permitted assigns), a company incorporated under the provisions of the Companies Act, 2013 and presently having its address at TB, 16th Floor, Prestige Shantiniketan, Bangalore, Karnataka 560048 - India

and

**Vithoba Hugar**, an individual, a citizen of Karnataka India and currently residing at #27, Sadashiva Nagar, Near Sai Park, Bijapur Vijayapura (hereinafter referred to as the ‘Inventor’);

and

**Vijaya Bhaskar Reddy Golla**, an individual, a citizen of Bangalore India and currently residing at #36, SKM Homes, Second Floor, House Number 4, S.V. Layout, Ayyappa Nagar, KR Puram, Bangalore 560036 India (hereinafter referred to as the ‘Inventor’);

Baxter and the Inventor are hereinafter individually referred to as “**Party**” and collectively as the “**Parties**”.

**BACKGROUND**

**1. OWNERSHIP OF THE INVENTION:**



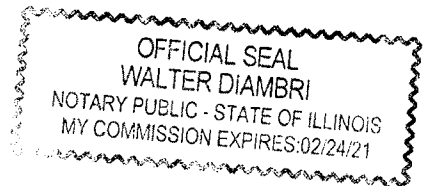
