RESTATED ARTICLES OF INCORPORATION

OF

MEDATA, INC.

The undersigned certify that:

1. They are the president and the secretary, respectively, of MEData, Inc., a California corporation.

2. The Articles of Incorporation of this corporation are amended and restated to read as follows:

"I

The name of the corporation is Medata, Inc.

II

The corporation elects to be governed by all of the provisions of the General Corporation Law (as added to the California Corporations Code effective January 1, 1977, and as subsequently amended) not otherwise applicable to this corporation under Chapter 23 of the General Corporation Law.

III

The purpose of the corporation is to engage in any lawful act or activity for which a corporation may be organized under the General Corporation Law of California other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the California Corporations Code.

IV

The total number of shares that this corporation is authorized to issue is Two Million (2,000,000), all of the same class, designated "Common Stock."

The shares of the corporation may be issued from time to time in two series designated, respectively, Voting Common Stock, of which the corporation is authorized to issue One Million (1,000,000) shares, and Nonvoting Common Stock, of which the corporation is authorized to issue One Million (1,000,000) shares. The rights, preferences, privileges, and restrictions of Voting Common Stock and Nonvoting Common Stock shall be equal and identical in all respects except that, unless otherwise provided by law, the holders of shares of Voting Common Stock shall have and possess the exclusive right to notice of shareholders' meetings and the exclusive voting rights and power, and the holders of shares of Nonvoting Common Stock shall not be entitled to notice of any shareholders' meetings or to vote upon the election of directors or upon any other matters. Upon the amendment of this article, each outstanding share is split into Ten Thousand (10,000) shares of Voting Common Stock.

V

a. The liability of the directors of this corporation for monetary

damages shall be eliminated to the fullest extent permissible under California law.

b. This corporation is authorized to provide indemnification of agents (as defined in Section 317 of the California Corporations Code) through bylaw provisions, agreements with the agents, vote of shareholders or disinterested directors, or otherwise, in excess of the indemnification otherwise permitted by Section 317 of the California Corporations Code, subject only to the applicable limits set forth in Section 204 of the California Corporations Code with respect to actions for breach of duty to this corporation and its shareholders.

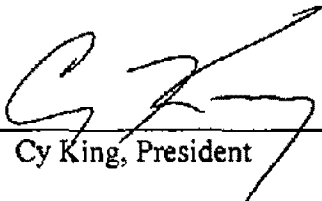
c. Any repeal or modification of this Article shall only be prospective and shall not affect the rights under this Article in effect at the time of the alleged occurrence of any act or omission to act giving rise to liability or indemnification."

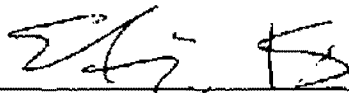
3. The foregoing amendment and restatement of the Articles of Incorporation has been duly approved by the board of directors.

4. The foregoing amendment and restatement of the Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902, California Corporations Code. The total number of outstanding shares of the corporation is Seventy-Four (74). The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than fifty percent (50%).
